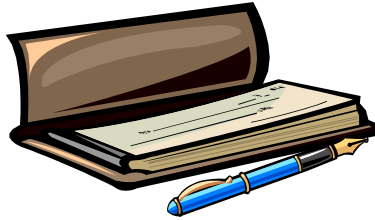

"Many people who might qualify are unaware that in Florida, low income individuals may apply to the clerk of the court for **Civil Indigent Status**. Based on the application, the clerk determines whether the applicant qualifies, and court filing fees may be waived." Florida Statute 57.082  
If an individual does not qualify, there is a possibility for payments to be arranged.
